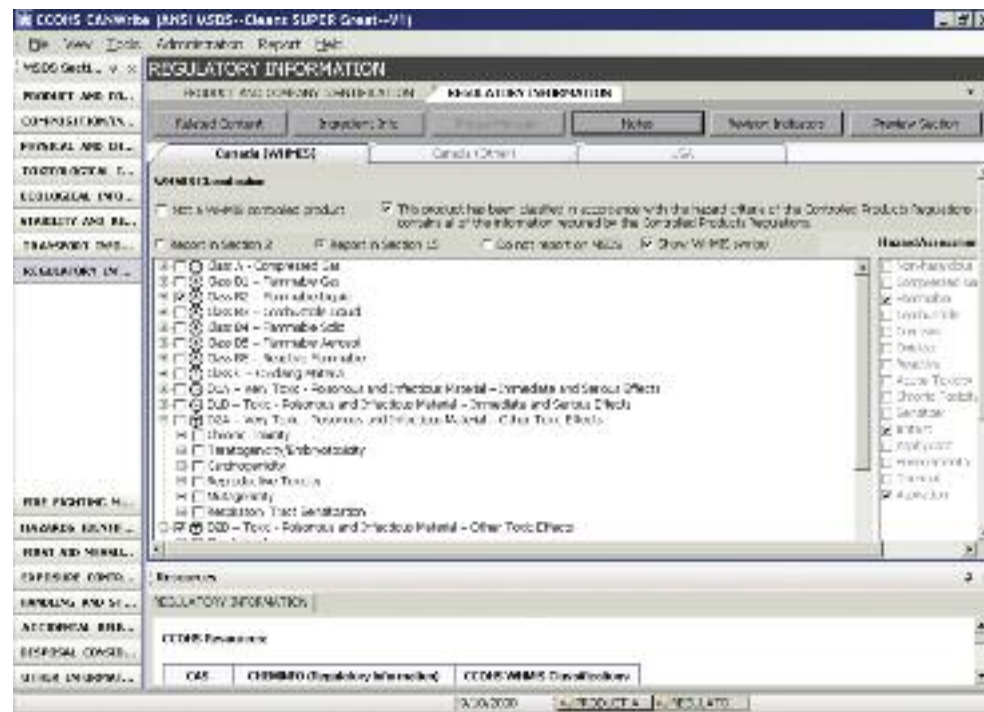
CCOHS is governed by a Council with representatives from employers, labour and governments and is committed to providing impartial and accurate information services.
